The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Aggravated First Degree Robbery

Minnesota Statute: 609.245.1

Maximum Sentence: 20 years imprisonment, a \$35,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 11/24/2022

Control #(ICR#): 22006435

Charge Description: On November 24, 2022, in Sibley County, defendant, while armed with a dangerous weapon, took, without consent, personal property from another in the person's presence and used force or the threat thereof to gain the property.

STATEMENT OF PROBABLE CAUSE

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court. Your Complainant is a peace officer employed by the Sibley County Sheriff's Office. In this capacity your Complainant believes the following to be true and correct:

On November 24, 2022, the Sibley County Sheriff's Office responded to a report of a burglary at 20310 291st Avenue in the County of Sibley, State of Minnesota. This residence is currently owned and occupied by Kevin and Corey Wolpern. Corey Alan Wolpern and Javier Marquez Rios were present during this incident and when officers arrived. Corey and Javier were found hand cuffed together.

Javier stated he was originally kidnapped from a hotel room in Chaska, Minnesota by a man identified as "Aron." On November 24, 2022, around 4:00 a.m., "Aron" came to Javier's hotel room and forced Javier to leave the room and go to 20310 291st Avenue in Sibley County. Javier and "Aron," left the Chaska, MN hotel room and drove to the residence.

Upon arrival, Javier and Corey were pushed into the attached garage by four suspects. One suspect had a revolver. Another suspect had a black semi-automatic pistol. The suspects took numerous firearms, tools, knives, swords, ammunition, and other miscellaneous items from the residence. These items were placed in three vehicles located at the residence. The suspects then handcuffed Corey and Javier together and left the residence, stealing the 3 vehicles at the residence.

Recently the Sheriff's Office showed Corey a Sequential Photo Display. Corey identified Oscar Silvas-Gamez (DOB 08-18-1990) and Julio Burgara-Lara (DOB 06-12-2001) as two of the individuals that robbed him at gunpoint at his residence. Given the violent nature of the allegations, a warrant is requested in the interests of public safety.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

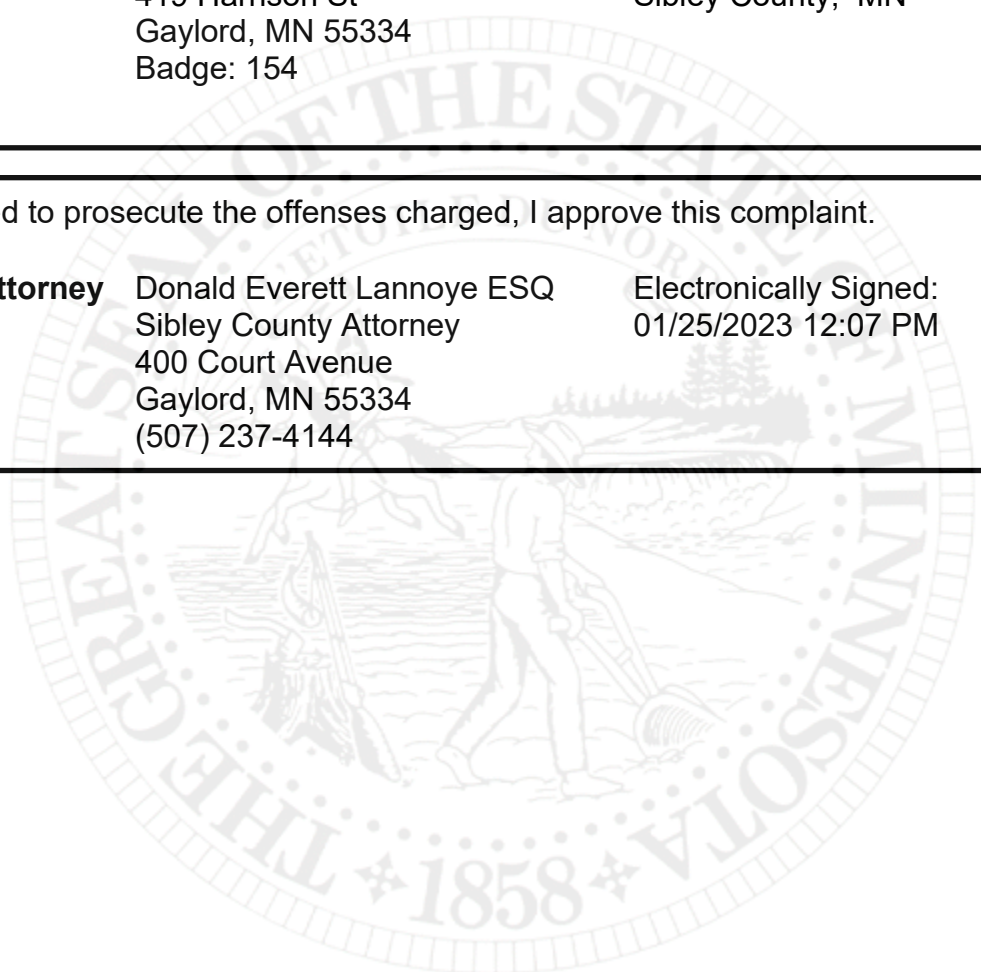
